It presents principles and results of previous and ongoing research throughout the world. The fourth edition follows the general pattern of the third edition (1985) closely. There are four major sections. The first covers cell structure, water relations, mineral nutrition, ion uptake and phloem transport. The final section is briefer, of two chapters only, on 'Environmental Physiology'. There are also appendices on units; measurement of radiant energy; and the processes of gene replication, transcription and translation.
